Less is More: Deprescribing in 5 Steps During a Home Visit

Polypharmacy is associated with adverse drug reactions, functional and cognitive decline, falls, increased health care utilization, and mortality. Half of patients above the age of 65 take five or more prescribed medications. Deprescribing has the potential to reduce up to 25% of all-cause mortality. A simple yet comprehensive five-step process of deprescribing for clinicians providing home care medicine will be presented, focusing on the importance of presenting deprescribing as a shared decision-making process with patients and families/caregivers in the context of their goals of care.

> Wound Debridement in the Home Setting: Safety and Efficacy

Debridement, the removal of nonviable tissue, is a fundamental procedure in wound care. Nurses caring for patients with chronic wounds in the home setting must achieve competency in this skill. This presentation will review the literature on debridement in chronic wounds, present recent clinical trial evidence for the safety and efficacy of a novel debridement tool, and suggest options for debridement by home health clinicians.

The World Health Organization (WHO) officially declared COVID-19 as a pandemic on March 12, 2020. The majority

of the roughly 300,000 deaths by mid-May were adults 65 years and older, and hospitalization rates were highest among older adults. As the world grapples with an accelerating number of new cases, healthcare systems have called for protecting vulnerable older adults from COVID-19 and increasing hospital bed capacity. Homebased medical care providers across the globe have seen a rise in demand for their services as more vulnerable patients stay home to reduce their risk of exposure to the virus. Before COVID-19, most medical home care practices focused on providing care to the millions of frail, homebound older adults who are often unable to access health care due to a combination of severe chronic conditions and functional impairments. Their numbers are rapidly increasing globally because of the aging population. They have the greatest need for primary/palliative care AND the most difficulty accessing these essential services. Many of these patients relied on emergency rooms as their primary source of medical care before COVID-19.

This international panel promotes aging in place from a multidisciplinary perspective, with a special focus on COVID-19. The presenters are experts in home care medicine from Brazil, Spain, Taiwan, France, China, and Japan. They will cover many themes: COVID-19 patients; new patients; home visits; telemedicine; PPE; personnel lost; administrative changes; new normal; and the future of home care medicine.

Congestive heart failure (CHF) is one of the most common admitting diagnoses for elderly patients and the associated mortality and morbidity are significant. The limitations of physical examination for assessment of volume status makes it difficult for home care providers to detect and treat occult congestion. Point-of-care ultrasound (POCUS) is highly accurate for the diagnosis CHF and recent research has shown that POCUS can decrease hospital admission and improve long term outcomes in CHF. In this session we review the evidence and provide an overview of relevant techniques such as lung, IVC, IJ, and echo.
